## **Chowan Perguimans Smart Start Partnership Training Descriptions**

### **Block Play**

Participants will learn that block play involves equipping educators with knowledge and strategies to effectively facilitate and enhance children's learning experiences during block play.

# **CPR/First Aid Training**

Participant will learn how to perform CPR/First Aid. Also, learn the rules and regulations for administering both.

## **Emergency Preparedness & Response in Child Care**

Emergency Preparedness and Response (EPR) in Child Care Training provides early educators with information and tools to prepare for many types of emergencies. The EPR in Child Care Training addresses NC Child Care Rules on emergency preparedness, current best practice recommendations, and guidance on completing the online EPR Plan.

# **Infant & Toddlers: Early Childhood Development and Resources**

This training covers infants and toddlers on their early childhood development and the resources available to them. Participants will review development milestones for infants and toddlers and gain specific knowledge of typical development, identify strategies and ways to communicate with parents/are givers when there are concerns related to a specific child's development, learn more about community resources related to developmental needs including who can and how to refer, and identify ways to collaborate amongst early educators, parents/caregivers, developmental support staff, and other community support members.

# **ITS/SIDS**

Learn how to provide a safe sleep environment for infants in a childcare setting. Training is required every three years and within four months of hire for staff and volunteers, and family childcare home providers licensed to care for infants.

#### **Medication in Child Care**

Participants will learn medication best practices in early care and education including receiving, documenting, storage, and disposal. They will learn about NC Child Care regulations, types of medication, and the forms that are required to be completed before giving medication. They will also learn the six rights of medication administration, as well as how to recognize, respond to, and report a medication error. This training does not prepare participants to give medication to children. Additional in-depth, in-person, skills based training should be undertaken by early educators who will responsible for giving medication to children.

## **Medication Administration Skills**

Participants will learn the skills needed to safely administer different types of medication to children, including oral, topical, inhalation, and instillation medication. It will not cover emergency/rescue medications such as types of injectable medication, infusion medication or rectal gels or suppositories.

## **Playground Safety**

Playground Safety training addresses playground safety hazards, playground supervision, maintenance, general upkeep of the outdoor area, age and developmentally appropriate playground equipment. This training offers a practical and Educational Interpretation of the North Carolina Child Care Commission's Playground Safety Ruled and how to conduct a playground audit.

# **Professionalism in Early Childhood**

Participants will learn what is professionalism in childcare, professionalism in teaching, ethics in early childhood and importance of professionalism.

# Teaching the 3C's: Creativity, Curiosity & Courtesy

This training is designed to bridge gaps as well as demonstrate how incorporating creativity, curiosity, and courtesy into classroom instruction can support the development of academic skills.

## The 3 A's: Attention, Appreciation and Affection

With the thrust of the mental health crisis and the attention drawn to social emotional learning in early childhood, this training is designed to share with provider's key elements to builds and sustain strong and healthy relationships with the children and families they serve in today's society.
